OPENING STATEMENT OF CHAIRMAN ROBERTS 13 Chairman Roberts. I now call to order a business 14 15 meeting of the Senate Committee on Agriculture, Nutrition, 16 and Forestry. 17 The purpose of this meeting is to consider the nominations of Gregory "Greg" Ibach to be the Under 18 19 Secretary for Marketing and Regulatory Programs, and William "Bill" Northey to be the Under Secretary for Farm and 20 21 Foreign Agricultural Services. 22 Let me point out that Mr. Ibach's experience leading 23 the Nebraska Department of Agriculture and Mr. Northey's 24 experience as the Secretary of Agriculture for the State of 25 Iowa, combined with their testimony before this Committee

and answers to the members' questions for the record, demonstrate that they are abundantly qualified to take on these roles at the Department. They will be vocal advocates for our farmers and ranchers and I fully support both of these nominations.

6 The Ranking Member and I have written the Department of 7 Agriculture to seek clarity on Mr. Northey's position. I 8 will enter it into the record, with no objection.

9 I am happy to support two very qualified nominees, Mr. 10 Northey and Mr. Ibach. And we are looking forward to 11 getting them down to the Department as soon as possible. So 12 I am glad we are all here right now.

13 I want to thank Chairman Roberts for working in a 14 bipartisan way to address the confusion surrounding Mr. Northey's position. As many of you know, Mr. Northey was 15 16 nominated to serve as the Under Secretary for one position. 17 However, USDA has said it intends for Mr. Northey to serve 18 in a different role than the position he was nominated for. 19 Chairman Roberts and I are working with the USDA to 20 clarify the titles and positions of the under secretaries 21 during this ongoing reorganization.

I am happy to support the nominees, Mr. Chairman. Chairman Roberts. A motion would now be in order to approve the nominations of Gregory "Greg" Ibach to be the Under Secretary for Marketing and Regulatory Programs and 3

William "Bill" Northey to be the Under Secretary of Farm and
 Foreign Agricultural Services.

5 Chairman Roberts. All those in favor, say aye.
