1 OPENING STATEMENT OF SENATOR BOOZMAN

2 Chairman Boozman. I call this business meeting of the
3 Senate Committee on Agriculture, Nutrition, and Forestry to
4 order. The purpose of this meeting is to consider the
5 nominations of Mr. Dudley Hoskins to serve as Under
6 Secretary of Agriculture for Marketing and Regulatory
7 Programs, and Dr. Scott Hutchins to serve as Under Secretary
8 for Research, Education, and Economics.

9 I support both these individuals and believe their
10 qualifications, experience in the private sector, and their
11 public service make them well suited for these roles.

12 I now recognize the distinguished Senator from
13 Minnesota, Senator Klobuchar, for any comments she would
14 like to make.

1 STATEMENT OF SENATOR KLOBUCHAR

2 Senator Klobuchar. Thank you, Mister Chair. While
3 there were some nominees on the agenda that I did not
4 support, I do support these two. I believe Mr. Hoskins is
5 qualified, and we have threats like avian flu and market
6 opportunities out there that we have to seize on. I believe
7 Dr. Hutchins is qualified, and I look forward to working
8 with him to ensure the best ag research possible, including
9 for our land grant institutions. I do remain concerned that
10 the USDA is not moving forward in a timely manner to get out
11 mandated dollars for competitive research programs, and I
12 urge USDA to be responsive to our request and hope that this
13 nominee will help us to get that done.

14 Chairman Boozman. Thank you, Senator Klobuchar.
