AMENDMENT intended to be proposed by Mr. WARNOCK

Viz:

1 Strike section 7112 and insert the following:

2 **SEC. 7112. DAVID A. SCOTT SCHOLARSHIP PROGRAM FOR**
3 **STUDENTS AT 1890 INSTITUTIONS.**

4 (a) DAVID A. SCOTT SCHOLARSHIPS FOR BACHELOR
5 OR GRADUATE PROGRAMS.—Section 1446(a)(1) of the
6 National Agricultural Research, Extension, and Teaching
7 Policy Act of 1977 (7 U.S.C. 3222a(a)(1)) is amended,
8 in the matter preceding subparagraph (A), by striking
9 “scholarships to individuals” and inserting “scholarships
10 (including for programs leading to a bachelor or graduate

1 degree) (to be known as a ‘David A. Scott Scholarship
2 for Students at 1890 Institutions’) to individuals”.

3 (b) MANDATORY FUNDING.—Section 1446(b)(1) of
4 the National Agricultural Research, Extension, and
5 Teaching Policy Act of 1977 (7 U.S.C. 3222a(b)(1)) is
6 amended by adding at the end the following:

7 “(D) FISCAL YEAR 2027 AND FISCAL YEARS
8 THEREAFTER.—Of the funds of the Commodity
9 Credit Corporation, the Secretary shall make
10 available to carry out this section \$15,000,000
11 for fiscal year 2027 and each fiscal year there-
12 after, to remain available until expended.”.

13 (c) DISCRETIONARY FUNDING.—Section 1446(b)(2)
14 of the National Agricultural Research, Extension, and
15 Teaching Policy Act of 1977 (7 U.S.C. 3222a(b)(2)) is
16 amended by striking “each of fiscal years 2020 through
17 2023” and inserting “fiscal year 2020 and each fiscal year
18 thereafter”.

19 (d) CONFORMING AMENDMENTS.—Section 1446 of
20 the National Agricultural Research, Extension, and
21 Teaching Policy Act of 1977 (7 U.S.C. 3222a) is amend-
22 ed—

23 (1) in the section heading, by striking “**SCHOL-**
24 **ARSHIPS**” and inserting “**DAVID A. SCOTT**
25 **SCHOLARSHIP PROGRAM**”; and

1 (2) in subsection (a)(3), by striking “each of
2 the 4 succeeding academic years” and inserting
3 “each academic year thereafter for which funding is
4 available under subsection (b)(1)”.
