3	(a) In General.—Subtitle C of title II of the De		
4	partment of Agriculture Reorganization Act of 1994 (7		
5	U.S.C. 6941 et seq.) is amended by adding at the end		
6	the following:		
7	"SEC. 236. RURAL HEALTH LIAISON.		
8	"(a) AUTHORIZATION.—The Secretary shall establish		
9	in the Department the position of Rural Health Liaison		
10	"(b) DUTIES.—The Rural Health Liaison shall—		

1	"(1) in consultation with the Secretary of
2	Health and Human Services, coordinate the role of
3	the Department with respect to rural health;
4	"(2) integrate across the Department the stra-
5	tegic planning and activities relating to rural health;
6	"(3) improve communication relating to rural
7	health within the Department and between Federal
8	agencies;
9	"(4) advocate on behalf of the health care and
10	relevant infrastructure needs in rural areas;
11	"(5) provide to stakeholders, potential grant ap-
12	plicants, Federal agencies, State agencies, Indian
13	Tribes, private organizations, and academic institu-
14	tions relevant data and information, including the
15	eligibility requirements for, and availability and out-
16	comes of, Department programs applicable to the
17	advancement of rural health;
18	"(6) maintain communication with public
19	health, medical, occupational safety, and tele-
20	communication associations, research entities, and
21	other stakeholders to ensure that the Department is
22	aware of current and upcoming issues relating to
23	rural health;
24	"(7) consult on programs, pilot projects, re-
